FUEL GAUGE

When the machine is armed, the fuel gauge displays the battery pack's remaining run time. The fuel gauge mirrors the fuel gauge on the battery pack. When less than 10% of charge is left, one light on the fuel gauge will flash 4 times. When the battery reaches 0% charge, the fuel gauge will flash 8 times. Charge the battery pack.

Also, when the product experiences ESD, the Bluetooth communication will be disconnected. It needs to be reset manually to recover.

In the event of a Bluetooth communication dropout outside of the exclusion band (2280MHz - 2603.5MHz) due to radio frequency interference, a manual reset may be initiated to reestablish the link.

We considered the results to be within our minimum acceptable performance level according to EN 61547:2009 / EN 301489-1 / EN 301489-17.

Connect only to single-phase AC current and only to the system voltage indicated on the rating plate. It is also possible to connect to sockets without an earthing contact as the design conforms to safety class II.

LI-ION BATTERIES

The rechargeable batteries are partially charged. The LED on the battery indicates the state of charge.

If it is not used for long periods, the rechargeable battery will switch to the non-operative state.

When fully discharged the rechargeable battery switches off automatically (depth discharge not possible).

Under extreme circumstances, the internal temperature of the battery could become to high. If this happens, the battery will shut down.

Place the battery on the charger to charge and reset it.

The state of charge can be read by pressing the button on the rechargeable battery. The battery can be left in the electric tool while the reading is taken but it must be switched off at least one minute beforehand (otherwise the display will be inaccurate). The number of LEDs illuminated indicates the state of charge. A flashing LED indicates a max. power reserve of 10%.

As a general principle, if the electric tool should fail to work after inserting the rechargeable battery, then the battery should be plugged into the charger. The displays on the battery and charger will then provide information about the condition of the battery.

In low temperatures work may continue at reduced output.

CHARACTERISTICS

After inserting the battery into the reception of the charger the battery will automatically be charged (red control lamp is illuminated continuously)

When a hot or cold battery pack is inserted into the charger (flashing red lamp), charging will begin automatically once the battery reaches the correct charging temperature (0°C...40°C). The max. charging current is flowing when the temperature of the Li-lon-battery is between 0°C and 30°C.

The battery's charging time is between 45 min and 90 min, depending on the state of discharge.

Once the battery is fully charged, the LED on the charger changes from red to green.

Remove the battery pack from the tool for charging when convenient for you and your job. Milwaukee batteries do not develop a memory when charged after only a partial discharge. It is not necessary to run down the battery pack before placing it on the charger.

As a general practice, it is best to unplug battery chargers and remove batteries when not in use. No battery pack

damage will occur, however, if the charger and battery pack are left plugged in.

The charger will keep the battery pack fully charged if it is left on the charger. The light indicator will be same as normal charging.

If the light indicator flashes red and green, check that the battery pack is fully seated into the bay. Remove the battery pack and reinsert. If the light continues to flash red and green, remove pack(s) and unplug charger for at least 2 minutes. After 2 minutes, plug charger back in and insert pack. If the problem persists, contact a MILWAUKEE service facility.

BATTERIES

Battery packs which have not been used for some time should be recharged before use.

Temperatures in excess of 50°C (122°F) reduce the performance of the battery pack. Avoid extended exposure to heat or sunshine (risk of overheating).

The contacts of chargers and battery packs must be kept clean.

For an optimum life-time, the battery packs have to be fully charged, after used.

To obtain the longest possible battery life remove the battery pack from the charger once it is fully charged.

For battery pack storage longer than 30 days: Store the battery pack where the temperature is below 27°C and away from moisture

Store the battery packs in a 30% - 50% charged condition Every six months of storage, charge the pack as normal.

BATTERY PACK PROTECTION

The battery pack has overload protection that protects it from being overloaded and helps to ensure long life. Under extreme stress the battery electronics switch off the machine automatically. To restart, switch the machine off and then on again. If the machine does not start up again, the battery pack may have discharged completely. In this case it must be recharged in the battery charger.

TRANSPORTING LITHIUM BATTERIES

Lithium-ion batteries are subject to the Dangerous Goods Legislation requirements.

Transportation of those batteries has to be done in accordance with local, national and international provisions and regulations.

- The user can transport the batteries by road without further requirements.
- Commercial transport of Lithium-Ion batteries by third parties is subject to Dangerous Goods regulations.
 Transport preparation and transport are exclusively to be carried out by appropriately trained persons and the process has to be accompanied by corresponding experts.
